## INTERDISCIPLINARY SERVICES AT WORK

Leaving an abusive relationship takes real courage. It is even harder when you are an immigrant and afraid that without your spouse you risk deportation and with that, the loss of your children.

“Linda” came to CLSACC in just that situation. Now successfully separated from her abusive husband and in sole custody of her children, she wrote to share her story of how CLSACC’s help turned her life around.

“I was in the midst of leaving an abusive relationship, with nothing but the clothes on my back and my two children, worried about not having proper immigration papers and the thought of losing custody of my children to my abusive husband when I found my Guardian Angels, Ellen Wilbur (Attorney) and Claire Donohue (Social Worker).

Each of these people taught me that I held all the answers both legally and mentally. In a two year battle in court for the protection of my children and a divorce that was both emotional and frightening, Ellen always told me straight, whether she thought things were going to turn out good or bad. Ellen never gave me false hope. This made me face the possible outcomes and gave me a sense of what I was fighting. Claire on the other hand never told me what to think, instead she made me think about the questions and doubts I had about who I am and forget what my abuser told me I was.

Now over three years later, I have secured myself a home, gotten my children into counseling and gone back to school. Last year I completed my GED (to which Ellen and Claire attended my graduation) and am currently enrolled in a Paralegal program that I will complete in October of this year. I am confident that both Ellen and Claire will also be present at this graduation.

Not only were these wonderful people who helped me through a terribly rough time as Attorney and Social Worker, they are great friends and great supporters of MY new me.”

Linda’s story highlights the effectiveness of CLSACC’s innovative Interdisciplinary Project. A social worker and lawyer working in tandem gave Linda the firm ground she needed to leave her abusive husband, protect her children, and gain control of her life.
