THE LEGAL PROGRAM PROVIDES FREE CIVIL LEGAL AID TO CLIENTS WHOSE INCOME IS AT OR BELOW 125% OF THE FEDERAL POVERTY LEVEL. THE PROGRAM PROVIDES A FULL RANGE OF SERVICES FROM ADVICE TO REPRESENTATION IN COMPLEX LITIGATION. CASES ARE HANDLED IN THE AREAS OF FAMILY LAW AND DOMESTIC VIOLENCE, HOUSING AND HOMELESSNESS PREVENTION, DISABILITY BENEFITS, AND IMMIGRATION AND REFUGEE RIGHTS (INCLUDING POLITICAL ASYLUM CASES, SPECIAL IMMIGRANT JUVENILES (SIJ) AND RELIEF FOR BATTERED IMMIGRANTS).
